

Risk Management Continuing Education for Licence Holders

The global financial crisis has intensified demand for training in risk management. Poor or inadequate risk management in financial institutions has been cited as one of the major contributors to the current financial quagmire.

Effective risk management depends on a strong and established risk culture - i.e. genuine awareness and control of risk throughout the organisation, and line-of-sight accountability.

This Risk Management course comprises a total of five topics - a capstone topic "Financial Risk Management", which provides a high-level overview of financial risk management; followed by four more detailed topics from each of the key risk classifications that provide greater depth and understanding of the key financial risks classifications, as listed below.
